### **WHAT ARE COOKIES AND WHY ARE THEY USED?**

Cookies are small text files stored by the websites you visit on your device or network server via browsers.

#### **The main purposes for use of cookies on our Website are as follows:**

- To improve and offer new features through the Website and to customize the features offered to you according to your preferences;
- To ensure the Website's, your and the Institution's legal and commercial security.

### **TYPES OF COOKIES USED ON OUR WEBSITE**

#### **Session Cookies**

Session cookies are temporary cookies that are used during the period our visitors visit the Website and are deleted once the browser is closed.

The main purpose of using these cookies is to ensure that the Website functions properly during your visit.

For example, they allow you to complete online forms comprising several pages.

#### **Persistent Cookies**

Persistent cookies are the cookies used to increase the functionality of the Website and to offer a faster and better service to our visitors.

These cookies are used to remember your preferences and are stored on your device via browsers.

Some types of persistent cookies may be used to offer you special proposals by considering the issues such as your purpose of using the Website.

Thanks to persistent cookies, when you visit our Website again using the same device, it is checked whether there are any cookies created by our Website on your device; and if yes, it is understood that you have visited the site before and the contents to be transmitted to you are determined accordingly and thus, a better service is offered to you.

## **COOKIES USED ON OUR WEBSITE**

### **Customization Cookies**

These are the cookies used to remember users' preferences while visiting different pages of different websites as well. For example, remembering your language preference that you have selected.

### **Analytical Cookies**

Analytical cookies are the cookies used to produce analytical results such as the number of visitors visiting the website, identification of the pages viewed on the website, website visit hours, website pages scrolling movements, etc.

## **INFORMATION FORM FOR WEBSITE VISITORS**

The principles that we follow when processing personal data collected through our website are set forth in this Privacy Policy. Your IP address details and website login and logout records may be collected as a result of your visit to our Website.

Your personal data in question may be collected by our Company's Information Technologies department electronically by automated means during your visit to our website.

Regarding your personal data, you have the right to find out whether your personal data have been processed or not, and if processed, to request information about such processing; to learn the purpose of processing and whether your personal data have been used for intended purposes or not; to find out the third parties to whom your personal data have been transferred; to request for correction of your personal data if they have been processed incompletely or inaccurately; to request for erasure or destruction of your personal data within the framework of the conditions stipulated in the PDP Law, to request for notification of such erasure and destruction actions taken accordingly to the third persons/parties to whom your personal data have been transferred; to object to any outcomes that may arise to your detriment through the analysis of your personal data exclusively via automated means; and to claim for compensation of any loss or damages that you may incur due to the unlawful processing of your personal data.

Our Company will conclude and finalize the request on a free-of-charge basis as soon as possible and within thirty (30) days at the latest according to the nature of request. However, if the process requires an extra cost, we will charge and collect the fee specified in the tariff as determined by the Personal Data Protection Board.
